## 2. Condition(s) of Appointment

The appointment for the post of Legal Advisor and Law Associate shall be done on contract or retainership basis for a period of 2 years extendable for further period of 2 years based on the performance of the individual. The initial pay shall be fixed based on the qualification, experience and performance and increased by 5% per annum on the initial pay.

#### 4. Mode of Selection

The process of selection of eligible candidates includes the following stages.

### a. Preliminary Screening Test

- ✓ All the eligible candidates to attend Preliminary Screening Test consisting of 50 Multiple Choice Questions each carrying 1 Mark for a total of 50 Marks.
- ✓ Preliminary Screening Test Venue & Date of the Examination will be intimated later.

#### b. Written Test

- ✓ Based on the performance in the Preliminary Screening Test, candidates shall
  be shortlisted and allowed to attend the Written Test.
- ✓ Written Examination will be an evaluation-based test and it relates to solving a legal problem which carries a total of 50 Marks.
- ✓ The Venue & Date of the Examination will be intimated later.

#### c. Oral Test

- ✓ Based on the performance in the Written Examination, candidates shall be shortlisted and called for the Oral Test.
- ✓ Oral Test will be conducted by the Selection Committee and it carries a total of 50 Marks.

The final selection of candidates will be based on the total marks secured by the candidate in the Written Test and Oral Test.
